


# CENTRAL DISTRICT BANKRUPTCY FILINGS CONTINUE TO DECLINE; CA(C) LEADS NATION IN *PRO SE* FILINGS

Based on the statistics released by the Administrative Office for the 12-month period ending December 31, 2015, the Central District of California ranked second in total filings (46,523\*), trailing the nation's leader, Illinois-Northern (48,161), by 3.4 percent and coming in 36.8 percent higher than the third-ranked court, Georgia-Northern (34,018). For the 12-month period ending December 31, 2014, the Central District's total filings were 11.9 percent greater than those of Illinois-Northern. In 2013, they were 37.2 percent greater.

The Central District continues to lead the nation in *pro se* filings, with 11,395 *pro se* petitions filed during the same period. The district's *pro se* filings make up 15.1 percent of the national total, and are 110.94 percent more than those of the second-ranking bankruptcy court, the Middle District of Florida. The Central District had the highest *pro se* filing rate of any bankruptcy court in the nation at 24.5 percent for the 12-month period, nearly triple the national average (8.9 percent). Although total *pro se* filings have decreased, the percentage of *pro se* filings to total filings is 1.1 percent higher in 2015 (24.9

total filings is 1.1 percent higher in 2015 (24.9 percent) than it was during the same time period in 2014 (23.8 percent).





Overall, the Central District's bankruptcy filings decreased 18.9 percent compared to the 57,356\* filings the district received during the same period in 2014. The filings of the top-ranked court, Illinois-Northern, decreased by 6.1 percent from the 51,274 received during that same period. Nationally, bankruptcy filings decreased 9.9 percent from the same period in 2014. Chapter 7 filings have decreased the most at 22.8 percent over the same period in 2014, followed by chapter 11 filings, down 8.4 percent, and chapter 13 filings, down 3.1 percent.

With the exception of calendar years 2006 (17,845) and 2007 (34,046), when the Court was recovering from the implementation of BAPCPA, filings have not been this low since 1985, when the Court took in 36,938 filings. The total is also down 67.4 percent from the 142,726 bankruptcy filings received in 2010, the highest filing year in the Court's history.

#### **NEXTGEN CM/ECF**

Over the next several years, federal courts around the nation will be upgrading to Next Generation (NextGen) CM/ECF. The bankruptcy courts currently using the NextGen version of CM/ECF are Oregon, Alaska, New Jersey, and the Southern District of California. NextGen appellate courts are the Second and Ninth Circuit Courts of Appeals. The Central District of California Bankruptcy Court is <u>not</u> on NextGen at the present time.

An attorney who practices in a NextGen court will be able to create and use a single username and password to connect to any of the courts currently on NextGen. This feature is known as "Central Sign-On." Please note that a NextGen username and password will <u>not</u> work for the Bankruptcy Court for the Central District of California, or any court that is not live on NextGen.

For the courts that have not yet upgraded to NextGen, including the Bankruptcy Court for the Central District of California, CM/ECF users will continue to use the same login and password that they use today. The Central District of California Bankruptcy Court will notify attorneys and electronic filers well in advance of its migration to NextGen CM/ECF. ### JUDGE CLARKSON SPEAKS TO ATTORNEYS ABOUT ETHICS

On January 28, Judge Scott C. Clarkson, along with William N. Lobel, Esq. and Christopher J. Green, Esq. of Lobel Weiland Golden Friedman LLP, presented on "Ethical Issues in Bankruptcy Debtor Representation" at the January Meeting of the Orange County Bar Association, Commercial Law & Bankruptcy Section. The program was held at the Tustin Ranch Golf Club and was attended by over 50 attorneys and law clerks.

Mr. Green set forth various hypotheticals, and Judge Clarkson and Mr. Lobel drew from their knowledge and experience, identifying ethical duties and obligations that may arise while representing parties in bankruptcy, including corporate debtors and officers, a group of creditors that may need to defend against preference actions, or married individuals. Handouts consisted of case summaries, rules governing professional conduct, statutes, and suggestions procured from Judge Jury's concurrence in *Tedocco v. DeLuca (In re Seare)*, 515 B.R. 599, 624 (B.A.P. 9th Cir. 2014) on avoiding ethical rules violations when counsel limits the scope of representation of a consumer debtor. Judge Clarkson wrapped up the session by encouraging attorneys to explain to their clients the importance of being honest and truthful with the information they provide, and not to fear seeking relief from the Court when clients are being unethical.

#### JUDGES PARTICIPATE IN IEBF'S ASK THE JUDGES NIGHT

On January 19, Judges Meredith A. Jury, Scott C. Clarkson, Mark S. Wallace, Wayne Johnson, Mark D. Houle, and Scott H. Yun served as panelists at the Inland Empire Bankruptcy Forum's Ask the Judges Night program. Held at the Marriott Riverside at the Convention Center, the program also installed the IEBF Board and recognized the Riverside pro bono program and volunteers. Attendees posed questions on topics ranging from cutting-edge legal issues to procedural issues. The program was approved for MCLE credit.

#### **TEN TIPS FOR ATTORNEYS**

- 1. Failure to pay filing fees within 24 hours of electronic filing results in a lockout from filing further documents in the CM/ECF system until the fees are paid.
- 2. Official Form 423 should be filed only if the financial provider has not already notified the Court of the debtor's completion of the course by filing the certificate.
- 3. Attorneys can now access the CM/ECF system to update their profile data.
- 4. A CM/ECF login issued by the District Court will not work in Bankruptcy Court.
- 5. Using a pop-up blocker will prevent LOU from opening.
- 6. If refiling petition pages, such as Form 101, you must use the event code "Addendum to Voluntary petition."
- 7. It is against Court procedure for a CM/ECF registered attorney to file a document for an unregistered attorney friend.
- 8. Using the "Search" key in CM/ECF is a good tool for looking up event codes.
- 9. The Statement of Social Security form should not be included when filing the petition in CM/ECF.
- 10. Staple the NEF on the back of the judge's copy.

### **CM/ECF TIPS**

#### **Employment Income Form**

As of December 1, 2015, the Debtor's Certification of Employment Income Form has a new name. The new form, #F 1002-1.EMP.Income.Dec, is entitled "Declaration by Debtor(s) as to Whether Income was received from an Employer within 60 days of the Petition Date."

## How Does An Attorney Become Certified in The Central District?

In order to get a login to file in the Central District, an attorney must register for CM/ECF online and take the online training course. If an attorney is already a registered user in another bankruptcy district, he or she can bypass the training by completing the online registration form and attaching to the form proof of filing (Notice of Electronic Filing) in the other bankruptcy district. #### Avoiding Unnecessary Filing Fees When Filing Amended Schedules D, E, or F And An Amended List of Creditors

When filing the amended schedules D, E, or F with an amended List of Creditors, be sure to use the event code "Amendment-Amending Schedules D and/or E/F." You may attach to the schedule a sheet of paper with only the new or modified creditors listed. This sheet represents the creditor matrix. Both documents may be filed using the single fee event code, "Amendment-Amending Schedules D, and/or E/F."

#### **NextGen Is Coming**

With the Next Generation CM/ECF upgrade, the new functionality will allow attorneys to maintain one account across all courts (district, appellate, and bankruptcy) and to sign in using one login and password for all NextGen courts where electronic (ECF) filers have permission to file.

Until the Court migrates to NextGen, ECF filers will still access our CM/ECF database the way they do now. After logging in, there is a pick list of NextGen courts to choose from. As of February 22, the current NextGen bankruptcy courts are Oregon, Alaska, New Jersey, and California Southern. The Ninth Circuit Court of Appeals and the Second Circuit Court of Appeals have also gone live with NextGen.
